
ADMISSION REQUIREMENT

- (1) The minimum qualifications for admission to the academic program are as follows:
- i. Bachelor's Degree in Muamalat/ Islamic Studies/ or related studies with a minimum CGPA of 3.00 or equivalent.

OR;

- ii. Bachelor's Degree in Muamalat/ Islamic Studies/ or related studies with a minimum CGPA of 2.70 and up to 2.99 and meets at least one (1) of the following criteria:
 - (a) University of Malaya graduate;
 - (b) Have at least one (1) year working experience in the relevant field;
 - (c) Published in the relevant fields;
 - (d) Scholarship holder;
 - (e) Government staff;
 - (f) Pass the interview by Faculty; or
 - (g) Pass the Faculty special assessment.

OR;



- (a) Have at least one (1) year working experience in the relevant fields:
- (b) Published in the relevant fields;
- (c) Scholarship holders;
- (d) Government staff;
- (e) Pass the interview by Faculty; or
- (f) Pass the Faculty special assessment.

OR;

iv. Bachelor's degree in Halal/ Muamalat/ Islamic Studies or related studies with CGPA 2.00 to 2.49 and meets at least one (1) (for UM graduate applicant) or two (2) (for non-UM graduate applicant) of the following criteria:

- (a) Have at least five (5) years working experience in the relevant fields;
- (b) Published at least one (1) article in a refereed journal in a related field
- (c) Pass the interview by Faculty (mandatory for non-UM graduate); or
- (d) Pass the Faculty special assessment.

OR;

v. Possess qualification from a recognized professional institution.

OR;

vi. Have other qualifications approved by the Senate from time to time.

OR:

- vii. APEL (A) qualification (only for Mixed Mode and Coursework programs).
- (2) Subject to the requirement to fulfill the minimum qualifications stated in sub-regulation (1). Applicants must also meet the special requirements set by the Faculty for each program.

LANGUAGE REQUIREMENT

Non-citizen applicants who obtained their degree from a university or institution of higher education which do not use English as medium of instruction and wish to enroll in or to write a dissertation in English are required to fulfill the English language competency requirements set by the University.

Non-citizen applicants who wish to pursue a Master's Degree program (other than certain programs at the Faculty of Languages & Linguistics and all programs at the Faculty of Medicine) must obtain at least the following results in one of the English proficiency exams mentioned below:

i. Minimum score of 550 for the Paper-Based Test (PBT), score of 213 for computerbased test (CBT) or score of 80 for the internet-based test (iBT) for the Test of English as a Foreign Language (TOEFL);

- ii. Minimum band 5.5 for the International English Language Testing System (IELTS) (Academic);
- iii. Scores according to the respective program standards if higher than (a) and (b);
- iv. For any program standard that places a lower TOEFL or IELTS (Academic) score than the University's minimum score, those programs must follow the minimum score that has been set by the University;
- v. A minimum score of 42 Pearson Test of Academic English (PTE Academic);
- vi. Minimum grade C for English subject General Certificate of Education (A-Level);
- vii. Minimum grade C Cambridge English: First (FCE);
- viii. Minimum grade C Cambridge English: Advance (CAE);
- ix. Minimum grade C Cambridge English: Proficiency (CPE); or
- x. Minimum band 4 Malaysian University English Test (MUET).

Notwithstanding the above, subject to Senate approval and based on the requirements of the Master's Degree program, the Faculty may consider qualifications/competencies in English other than those stated in paragraph (1) above.

Non-citizen applicants with the following backgrounds are exempted from the prescribed English language qualification requirements:

- (a) Originating from a Country that uses English as the National Language;
- (b) Use academic qualifications from institutions that use English as a full medium of instruction; or
- (c) Completed a study in Malaysia and wish to pursue higher education subject to condition (b).
