

# GUIDELINE FOR THE UNIVERSITY OF MALAYA PARTNERSHIP GRANT

#### 1.0 INTRODUCTION

The Partnership Grant is a scheme provided by the University of Malaya to researchers who receive international and industrial **RESEARCH FUNDS** from international institutions/agencies or national/international industries, to carry out R&D projects that can contribute to the discovery of new ideas and the advancement of knowledge in applied sciences, focusing on high impact and innovative research.

This Partnership Grant is an incentive and awarded as a separate grant to researchers who have successfully secured international/industrial research funds<sup>1</sup>. Researchers who received international/industrial research funds and interested in applying this Partnership Grant must send in an application to Centre of Research Grant Management (PPGP)<sup>2</sup>. Approvals are subjected to panel's decision.

- 1. The research fund must be administered by University of Malaya
- 2. Application can only be processed after the recipients/researchers and University of Malaya had received the international/industrial research funding.

\*This Partnership Grant is available ONLY for research funds received in the year 2014 and onwards.

## 2.0 OBJECTIVES

To encourage researchers to source out international/industrial grants for research project.

#### 3.0 ELIGIBILITY CRITERIA

This fund is open to all researchers who are successful in securing **RESEARCH FUNDS** from the international institution/agencies or national/international industries.

#### 4.0 QUANTUM OF FUNDING

50% of the awarded amount to a maximum of RM 500,000 for those grant received above RM500,000. The amount awarded will depend on the availability of fund.

#### 5.0 SCOPE OF FUNDING

The funding can be utilised for the following categories which are directly related to the project:

## 6.0 PROJECT DURATION

- The project duration is as stated in the contract between the two parties.
- Requests for project extensions for this grant scheme must be made to the Director of IPPP's office.

## 7.0 SELECTION CRITERIA OF THE PROJECT

- The project must be scientifically sound, technically feasible with achievable milestones, and has the potential for further development and commercialisation.
- Research competence: The research team must have the knowledge and competency to carry out the research successfully to completion with clear and measureable expected output and outcome.

## 8.0 OWNERSHIP AND USE OF R&D EQUIPMENT

All R&D equipment purchased under this grant will belong to the UM and equipment is not for the exclusive
use of the institution only but ought to be shared with other researchers within the UM.

## 9.0 PUBLICATIONS

- Researchers are expected to publish the results of their projects, internationally in Q1 or Q2 ISI/WOS publication.
- All publications MUST acknowledge this grant and grant number.
